Circular on identifying which First Level Regulatory Examination to write

FAIS Circular 8 dated **29 October 2010**, *Circular on First Level Regulatory Examinations: KI Level 1: Category I, II, IIA, II and IV (RE 1) and Representatives (RE 5)*, and **FAIS Circular 9** dated **5 November 2010**, *Circular on Preparation for the First Level Regulatory Examinations*, provided the following information:

- Who should be writing the first level regulatory examinations
- Details regarding the examination bodies where one can register for the examinations
- The pass mark of the regulatory examinations (RE1 and RE5)
- The cost of the regulatory examinations
- How to prepare for the regulatory examinations
- The format of the regulatory examinations
- The examination conditions that apply to all regulatory examinations

This circular provides you with information regarding how many first level regulatory examinations will be made available and how to identify which regulatory examinations applies to you.

The First Level Regulatory Examinations consist of the following **five (5)** examinations:

The following descriptions for each of these examinations will assist you in identifying which examination applies to you:

RE No	Regulatory Examination	Descriptor
RE1	Key Individual Level 1: Cat I, II, IIA, III and IV (General)	This is a <u>general examination</u> that applies to <u>all key individuals and sole proprietors in all the Categories</u> . This examination consists of 80 questions. All sole proprietors and key individuals who are responsible for managing and overseeing a business relating to the rendering financial services for FSPs in Category I, II, IIA, III and IV are required to write this examination.
RE2	Key Individual Level 1: Cat 1.1 & 1.19	This examination applies only to sole proprietors and key individuals who are responsible for managing and overseeing the business relating to the rendering financial services for FSPs in Category I that only deals with <u>Assistance Business Policies and Friendly Society Benefits</u> . Where sole proprietors and/or key individuals deal only with <u>Assistance Business Policies and Friendly Society Benefits</u> they will not be required to also complete the RE1 (general) examination. This examination consists of 80 questions.
RE3	Key Individual Level 1: Cat II & IIA	This is a specific examination that only applies to sole proprietors and key individuals in <u>Category II and IIA</u> . This examination consists of 30 questions. All sole proprietors and key individuals who are responsible for managing and overseeing the business relating to the rendering financial services for FSPs in Category II (Discretionary FSPs) and IIA (Hedge Fund FSPs) are required to write this examination <u>in addition to the RE1</u> .
RE4	Key Individual Level 1: Cat III	This is a specific examination that only applies to sole proprietors and key individuals in <u>Category III (Administrative FSPs)</u> . This examination consists of 30 questions. All sole proprietors and key individuals who are responsible for managing and overseeing the business relating to the rendering financial services for FSPs in Category III are required to write this examination <u>in addition to the RE1</u> .
RE5	Representatives	All <u>Representatives</u> , including those employed or mandated by an FSP, who render a financial service to a client (excluding a person rendering clerical, technical, administrative, legal, accounting or other service in a subsidiary or subordinate capacity which does not require judgment or does not lead to a specific transaction in respect of a financial product in response to general enquiries) are required to write this examination. This examination consists of 50 questions.

Example:

- If you are a key individual for a Category I FSP only, then you will only be required to write the RE 1.
- If you are a key individual for a Category II FSP, then you will be required to write the RE 1 and RE 3.
- If you are a key individual for a Category III FSP, you will be required to write the RE 1 and RE 4.
- If you are a key individual for a Category IV FSP, you will be required to write the RE 1 only.
- If you are a key individual for an FSP that only deals with Assistance Business Policies and Friendly Society Benefits, then you will only be required to write the RE 2.
- If you are a representative, you will be required to write the RE 5 with the exclusion of those representatives that only deals with Long-term Category A or Deposits, as these representatives are exempted from writing the regulatory examination.
- If you are a key individual for a Category I FSP and you are also a representative then you will be required to write the RE 1 and RE 5.

Please note:

Currently the RE 1 and RE 5 are available and you may register at any of the four examination bodies to write these examinations. The RE 2, RE 3 and RE 4 are not available as yet, and we will communicate their availability as soon as they are ready to roll out.

Additional information regarding the regulatory examinations is included in the preparation guide available on the FSB website under the FAIS tab. In order to complete these examinations successfully, it is critical that you prepare thoroughly. You will find guidelines in terms of how to prepare included in the preparation guide.

A three hour satellite broadcast will take place on 10 February 2011 from 09:00 to 12:00 where all aspects regarding the regulatory examinations will be discussed. More information regarding the details of this broadcast will be communicated in a brochure to the industry, and details will also be available on the FSB website.

The FSB is delighted to host the first series of interactive workshops between the regulator and the industry, using satellite technology.

What is an interactive workshop?

This means that we will use satellite broadcast technology to broadcast live sessions from a studio in Stellenbosch to 17 venues across South Africa. Participants can choose which venue to go to. They will then view the live broadcast at the venue, and be able to participate in the session.

Why are we using this technology?

There are approximately 14 000 authorised financial services providers in South Africa. Using satellite technology means that we can reach more than 600 people at the same time. The advantage is that there are venues in every province, bringing the sessions a bit closer to you.

Are there costs involved?

It doesn't cost you anything to attend the session. Please note that if you need to travel to a venue, the travel costs are for your own account.

What must I take to a session?

You only need some paper and a pen to take notes. There will be an administrator at each venue, who will be able to help you participate in the discussions. If you have a laptop and 3G internet connectivity, you will also be able to use that during the sessions, but it is not a requirement for attendance or participation. We will post the slides on the FSB website after each session.

What can I expect at the venue?

You can expect a TV screen, tables and chairs. The venues are used by the University of Stellenbosch for tutorial sessions with their students. The venues are thus standard classroom issue, and not smart. Please do not expect conference venue quality.

Are there refreshments at the venues?

We cannot supply any refreshments at the venues, so please take your own water and lunch bag along.

What time must I be there?

Please check the start and end time of the session carefully. Sessions will start promptly, so we recommend that you are at a venue at least 15 minutes before the start time.
